- 1) To store your boat at the Barbados Cruising Club you must be a fully paid up local member.
  - 2) There is a \$200 refundable deposit to be paid on all vessels stored. This will be returned once the boat is removed from the property. If the Sailing Club has to remove the boat from the property, the deposit will be forfeited.
  - 3) Only local single and family memberships can store vessels and equipment on site.
  - 4) Vessel storage at the Barbados Cruising Club is subject to availability and is at the discretion of the Sailing Captain.
  - 5) For any vessels found to be on site without the permission of the Sailing Captain the owner will be notified and if non-compliant with the removal/payment request, will have their vessel removed from the Club, for which they will be charged.
  - 6) Vessel owners are responsible for the care and safety of their own equipment.
  - 7) Boat owners are responsible for the maintenance and care of their boats, including ensuring the boat is clear of water and debris (to ensure mosquitoes cannot breed, which is a health code violation). This must be done on a weekly basis and you must sign in with Paddle Barbados. Failure to do this can result in a charge of \$50 per violation for clearing the boat, or the boat being removed from the property at the owner's cost for repeated violations. If we have to contact you 3 times for a violation and you do not respond adequately, your vessel will be removed and your deposit forfeited.
